Rebate #1: Existing Irrigation Systems

Overview

Cascade Water Alliance is pleased to offer rebates up to \$400 to encourage homeowners and businesses to improve the efficiency of their in-ground irrigation systems. A well-tuned, efficient irrigation system can save thousands of gallons of water during the summer when drinking water supplies are in greatest demand.

This rebate is offered for customers who have an existing in-ground irrigation system at least 2 years old. A rain sensor and new Smart Controller will allow you to match the watering needs of your lawn and garden to current weather conditions, minimize or eliminate watering when it rains and more easily maintain a healthy, attractive landscape.

Customers of Cascade members are eligible for any rebate or other conservation program offered by Cascade Water Alliance. Cascade members include: Bellevue, Covington Water District, Issaquah, Kirkland, Redmond, Sammamish Plateau Water and Sewer District, Skyway Water and Sewer District and Tukwila.

Eligibility

1. The account must be served by a member of Cascade Water Alliance.
2. The account must be in good standing.
3. The irrigation system must be in-ground, operated by an automatic controller (clock) and at least 2 years old.
4. Smart Controllers must be chosen from the Smart Water Application Technology (SWAT) list of products. For more information visit www.irrigation.org/smartwater/ia-tested.asp or call (425) 453-1810.
5. Conservation Controllers must offer water management features such as multiple programs, cycle and soak, water budgeting and interval scheduling. For more information call (425) 453-1810.

Instructions

1. Verify that you are a customer of a Cascade member.
2. Have your irrigation system inspected by a licensed landscape or irrigation contractor. For more information on choosing a contractor visit www.cascadewater.org/con_rebates or call (425) 453-1810.
3. If you and your contractor determine that your irrigation system will benefit from a rain sensor or new controller, purchase the appropriate hardware for your system and install in accordance with manufacturer's specifications.
4. Mail, fax or email the completed application with appropriate signatures and copies of receipts of the installed products to the following address within 90 days of installation:

5. Keep your old controller for 30 days after submittal of the rebate application. Cascade reserves the right to inspect the old and new controllers. Rebate checks are usually sent within 4 weeks of application submittal.
